## Exhibitor Agreement

**Set Up and Breakdown** - Exhibitors may begin setting up displays as early as 6:00 AM on Friday morning. Break down must be completed and all exhibit materials removed by 12:00 PM on Sunday, the last day of the conference.

**Communications** - The hotel communications department can accommodate your phone line and networking requirements. Please let us know if you will require these services, and arrangements will be made at the cost of the exhibitor.

**Storage Space** - The hotel may be limited in the amount of storage space available; therefore, it is important that exhibitors be advised not to ship exhibit materials and equipment to the hotel without first contacting the hotel. If exhibits are shipped to the hotel without prior arrangements, the hotel will:

- Attempt to contact the shipper and request re-consignment to your trade show contractor
- If re-consignment is not possible, the hotel will accept the goods. Such costs are the responsibility of the exhibitor.

**Sharing / Subletting Space** - No exhibitor shall assign, sublet, or apportion the whole or any part of the space allotted, or have representatives, equipment, or materials from other than their own firm in the said space. Management policy prohibits subcontracting of the exhibit space. Should an exhibitor decide to cancel, exhibit space reverts back to Aesthetic MD, and exhibit cost will be refunded on the following basis: 30 Days prior to event – 100% Refund, 10 Days prior– 50% Refund, Day of event – No refund will be issued.

**Exhibit Regulations** - Exhibitors agree to abide by all conditions under which space at the hotel is leased to Aesthetic MD. Exhibitors accept responsibility for informing all of their employees and agents of these conditions, and agree that they will abide by them also. The exhibitor represents and warrants that it will not use the name, logo, or seal of Aesthetic MD in promotional or informational material without the written consent of Aesthetic MD. All of the rules and regulations are to be construed as part of all space applications. Aesthetic MD reserved the right to interpret them, as well as make final decisions based on Aesthetic MD's sole discretion, on points these rules do not cover. In all interpretations of the rules and regulations, the decision of Aesthetic MD is final.

**Liability** – Aesthetic MD acts for exhibitors and their representatives in the capacity of agent, not as principal. Aesthetic MD assumes no liability for any act of omission or commission in connection with this agency, including, but not limited to, any loss or damages suffered by an exhibitor as a result of any act or omission of any party. Exhibitors and their representatives hereby release Aesthetic MD from any and all liabilities for loss or damage ensuing from any cause whatsoever, except for claims for damages or injuries resulting from Aesthetic MD's failure to fulfill its obligations as set forth in this prospectus.

In addition, each exhibitor and its representatives agree to indemnify and hold harmless Aesthetic MD for all costs, damages, and liability, including attorney's fees, claimed against Aesthetic MD based upon acts or omissions of the exhibitor or any of its employees or agents. Aesthetic MD disclaims any and all liability for injury or other damages to an individual based on products or services displayed at the meeting for all claims that may arise out of the use of the displayed products or services. Exhibitors shall indemnify and hold harmless Aesthetic MD and its officers, directors, employees, agents, and contractors from any judgment, loss, or other expense (including attorney's fees) arising from allegations, claims, or lawsuits relating to (I) product or services offered by exhibitors or (II) actions of exhibitors, their employees, or agents.
